The policies require that all public donations and utility grants are used solely for winter/summer utility and related assistance for the qualified underprivileged. Administrative and other expenses related to the organization are underwritten by the officers and members of the board of directors, grants, and/or sponsors of specific fundraisers.

Legal services, banking, graphics and certain printing for fundraisers are donated by various corporations. The local media (newspapers, television and radio) help by running public service announcements, press releases and fundraiser promotions free of charge.
